The puppy has also been dewormed at 2, 4, 6, and 8 weeks of age and will be microchipped prior to going home. To the best of the Breeder's knowledge, the puppy is healthy and free of illness at the time of transfer to the Buyer or shipping company.

If the puppy is shipped, the Breeder is not responsible for any illness or injury that may occur after the puppy has been accepted and cleared by the shipping company.

The Buyer agrees to provide proper care, veterinary attention, nutrition, housing, and training for the dog.

The dog is sold strictly as a pet/companion and is not to be used for breeding. Any intentional or accidental breeding will result in a \$6,000 penalty.
